TERMS & CONDITIONS

MEMBERSHIP STATUS

- Membership shall entitle members to the use of the facilities of E.J Churchill Shooting Ground (subject to the rules) and shall comprise persons in such classes of the membership as the Owner decides from time to time.
- Admission to the membership shall be at the sole discretion of the Owner. The decision of the Owner on whether any candidate shall be admitted shall be final and the Owner shall not be required to give any reason for its decision.
- Every candidate shall complete & lodge with the Membership Secretary an appropriate application form stating the applicant's name, age, address & any further information
- The application form requires. Junior membership shall be counter signed by a parent or guardian where the junior is under 18 years of age. The applicant shall be admitted at such times as the Owner shall decide. Any omission from or inaccuracy in the particulars relating to, or description of, any applicant shall render his/her admission voidable at the discretion of the Owner. Membership shall run from year to year on a date decided by the Owner. Immediately upon the admission of a member he or she shall be entitled to all benefits and privileges of the club and shall be bound by these terms and conditions.
- The owner shall have the power to appoint & dismiss Honorary & Temporary Members at their discretion.
- The amounts of joining fees, subscriptions, guest fees, usage process & all other sales, prices & charges shall be determined by the Owner and displayed on E.J Churchill Shooting Ground premises.
- All entrance fees and subscriptions shall be paid as required.
- Membership of E.J Churchill shall cease;
 - A) By notice in writing addressed or email to the membership secretary resigning membership of E.J Churchill
 - B) By failure to pay the annual subscription within two weeks of it falling due and written renewal letter having been sent. In the interim no member whose membership is not up to date will receive their membership benefits.
 - C) The Owner or a Senior Manager in their absolute discretion and without being required to assign any reason, termination or suspending the membership of any member.
- Members' subscriptions may not be reimbursed in whole or in part under any circumstances, unless decided by the Owner.
- A duly admitted and paid-up member of E.J Churchill shall be entitled to all the benefits and privileges of E.J Churchill & shall be bound by the Terms & Conditions of E.J Churchill for the time being so in force but shall acquire no proprietary rights in the E.J Churchill premises or in any of its facilities.
- Membership benefits are non-transferable and any member who allows his/her membership to be used by a non-member shall be liable to immediate termination of the membership.
- Every member shall always ensure that E.J. Churchill is in possession of his/her main home address to which any correspondence should be addressed. Any letter or notice sent by post to that address shall be deemed to have been received 48 hours after it was posted.

E.J. CHURCHILL SHOOTING GROUND

- All persons entering E.J Churchill or who are using any of the facilities do so at their own risk.
- Neither the owner or E.J Churchill employees will be responsible for any loss or damage to property nor any other articles of value belonging to members, or their guests howsoever caused.
- All members and their guests must wear ear protection, hats and safety glasses when shooting or in the proximity of shooting.
- The Owner, any Senior Manager or E.J Churchill staff may exclude, refuse admission, or eject any member or guests of a member from the club premises and grounds without giving reason for such exclusion, refusal, or ejection. If any member fails to comply with the Terms & Conditions whilst on the E.J Churchill premises or in the opinion of the owner or manager conducts himself or herself whilst on E.J Churchill premises in such a manner as brings the E.J Churchill into disrepute, the owner or any Senior Manager may in their absolute discretion either caution or suspend or expel any such member without assigning any reason for such action or giving any explanations to such a member. Any dangerous or careless act will be an automatic reason for immediate termination of membership.

CLAYMATE, LESSONS & CADDIED ROUNDS

- Members are required to pay for all goods and services they or their guests purchase before they leave the premises. No credit whatsoever is given.
- 48 Hour cancellation policy applies to Members & Non-Members. All members will be invoiced for the cancellation fee for any appointment which is missed or cancelled within 48 Hours.
- The Owner from time to time may add to, repeal, or amend any of these Terms & Conditions. Notice of such amendments shall be displayed on the club premises. All such amendments shall be binding on all members.
- The Owner shall be the sole authority for the interpretation of these terms and conditions.
